## **Playing rules**

Upon reservation of a court, all renters, players and visitors must explicitly recognise these rules and the associated obligations no later than the entering of the reservation in the system.

The reservation of a court must be finalised in writing. Court reservations can be cancelled free of charge on both sides a minimum of 3 calendar days before the reserved time slot. The court rental is to be paid before the start of the game.

One hour of play amounts to 60 minutes and always starts on the hour. The court-side clock is decisive for the start and end times of the game. Use of the court is not transferable. Any sub-renting or transfer of usage of the court may take place only with the consent of the renting company. Should unused courts be played upon without authorisation, the standard court rental is payable by the user for each commenced hour of play. The facility shall be liable for the loss of use of the court and playing possibilities only if it is at fault.

Renters, players and visitors to the facility must follow the instructions of beach38° employees. In the case of repeated violations of these rules or the orders of beach38° employees, which may affect operational safety, a sanction may be applied by the facility. The obligation to pay the court rental remains unaffected.

The courts are to be treated gently and with care. Renters, players and visitors are responsible for all damage to and contamination of the facility and its fixtures. The legal representative shall be liable for minors. Immediately after the game, the courts are to be left clean, using the tools provided for this purpose. Throwing away or leaving waste outside of the container provided for this purpose is prohibited. Taking glasses, glass bottles, food etc. onto the playing surfaces is prohibited.

The adjustment of the nets is permitted only under the guidance of beach38° employees. Balls can be borrowed against a deposit. Instruments and equipment should be used only for their intended purpose. Heating and lighting systems may only be operated by beach38° employees.

Renters, players and visitors to the facility must behave in such a way that safety and order are not affected and other people are neither threatened nor harassed. In the case of an assault or the use of coarse insults against another player, visitor, beach38° employee or third party, an immediate sanction shall be issued by the facility. The obligation to pay the court rental remains unaffected.

Changing rooms are available for use. Access to the changing rooms is permitted only for renters and players.

Access to the courts is via the stairs below the Gallery. Entrance to the restaurant in sportswear is prohibited.

Entrance to the dressing rooms adjacent to the Health Loft is prohibited. In case of wrongful conduct a ban may be imposed and the cost of repairing any damage or contamination may be invoiced.

The affixing of posters, announcements, etc. requires the prior express permission of the facility.

Lost property should be handed in to Reception.

Smoking is absolutely prohibited in the entire indoor area as well as on the outdoor courts! For reasons of hygiene pets are not allowed on any part of the site!

Bringing food and drinks from outside is not permitted!

Please be vigilant of your clothes and valuables, and in particular cash, credit cards, etc. We accept no liability for the loss of and damage to clothing and other items.

Renters, players and visitors use the entire facility (indoor and outdoor), including all ancillary rooms and surfaces at their own risk. This also applies to access roads and parking. beach38° is liable, according to the legal provisions, for the compensation of damages caused by a intentional or grossly negligent breach of duty by beach38° or a legal representative or agent of beach38°. Any further liability of beach38° for damages is excluded. The unlimited liability for damages resulting from the culpable injury to life, body or health remains unaffected.
